Price Column Identification & Initial Order Requirements

Our pricing policy allows dealers to purchase our products at a discount level based on their initial stocking order and/or yearly sales volume. We have established three discount levels.

Trade Column

This price level is extended as a courtesy to auto parts stores, body shops, restoration shops and low volume buyers. An initial request must be made on company letterhead.

Jobber Column

An initial stocking order of \$800.00 is required in order to receive Jobber pricing. There is no minimum re-order amount. A yearly minimum sales volume of \$2,500.00 must be maintained in order to maintain Jobber account status.

Wholesale Column

An initial stocking order of \$1,500.00 is required in order to receive Wholesale pricing. There is no minimum re-order amount. A yearly minimum sales volume of \$5,000.00 must be maintained in order to maintain Wholesale account status.

PLEASE NOTE: In an effort to establish pricing equality and consistency (within our dealer network) we will monitor all dealer sales on a yearly basis and adjust discount pricing respectively.

Dealer Requirements

All new dealers will be required to provide us with the following:

- 1) Copies of your city and/or state business license.
- 2) A completed and signed dealer application.
- 3) A signed and dated resale certificate/card to receive tax exempt status (California based businesses only).

Terms & Conditions

Buyers orders are accepted subject to the following conditions which supersede any conflicting conditions contained in the buyer's purchase order.

Prices

Prices are subject to change without notice. Possession of this catalog does not authorize discount pricing. M&H Electric Fabricators Inc. reserves the right to adjust a dealers discount price level or revoke dealer status at any time. Shipments will be billed at sellers prices in effect on the date shipments are made.

Backorders

Orders received by FAX will be shipped complete unless otherwise instructed. When placing your order by phone you will be informed of any backordered items, you may choose to have your order shipped complete or we will ship the in stock items and ship the backordered items at a future date.

Delays

Delivery dates indicated on quotations and/or acknowledgments of orders are accurately estimated, but are not guaranteed.

Shipping Terms

All products will be shipped via UPS or Federal Express ground service, F.O.B. Santa Fe Springs, CA 90670.

Claims

Claims for errors, deficiencies or imperfections must be made in writing or by phone within seven (7) day's of receipt of goods. The absence of such notice within the specified time will constitute an acceptance in conformity with the purchase order and a waiver of all such claims.

Returns & Refusals

Normal dealer returns for items ordered in error will be accepted for credit only. **NO REFUNDS WILL BE ISSUED.** Returned merchandise must be in unused condition and in the original packaging. Credit will be issued only for the amount actually paid for the product without consideration for freight. * All items are subject to a 20% restocking charge. No returns will be accepted without prior authorization. Please contact us for a Return Material Authorization number (RMA). Special order items and custom modified harnesses (i.e. H.E.I., Internal Regulated Alternator, etc.) are non-returnable and non-refundable. Customers refusing a C.O.D. shipment will be billed a 20% restocking charge plus shipping to and from the destination. Your account will be put on hold until all charges are paid.

* If you are not 100% satisfied with the **quality** of a harness, cable or switch we will waive the normal restocking charge and give you a full credit or refund. Does not apply to custom modified and special order items.

Cancellation of Special Orders or Custom Modified Harnesses

In case of cancellation of a special order or a custom modified harness, the buyer will be liable for completed production, for the material in process of fabrication for the order, for materials purchased specifically for the order or contract and for any related unamortized special cost. Special order items are defined as items not normally stocked and are built to order.

Method of Payment

Dealer orders will be shipped C.O.D. cashiers check or money order only. We will ship C.O.D. check OK only after receipt and approval of our check OK form. Dealers can now save on C.O.D. charges by billing their orders to a credit card. We accept Visa, Master Card, AMEX and Discover. Prepaid orders are always welcome. Open Accounts are only available to dealers that have been reselling our product for one year or more. Open Account terms are Net 20 days, 1-1/2% per month late charge after 30 days. Returned checks are subject to a \$30.00 bank charge.

Indemnity

With respect to all goods manufactured either in whole or part to buyer's specifications buyer will protect and indemnify the seller against all claims for damages or profits arising from infringement of patents, designs, copyrights or trademarks.

Warranty

Seller's applicable standard warranty policy applies to all products manufactured by seller.
